About this document

When to use this target market determination

This target market determination (TMD) seeks to offer customers, distributors and staff with an understanding of the class of customers for which this product has been designed, having regard to the customer's objectives, financial situation and needs.

This document is not intended to provide financial advice. Customers must refer to the Rabobank Online Savings Terms and Conditions which outline the relevant terms and conditions under the product.

Product to which this target market determination applies

This TMD applies to the PremiumSaver Account referred to in the following documents:

- Rabobank Online Savings Terms & Conditions
- Rabobank Australia Limited Financial Services Guide

Date from which this target market determination is effective

10 May 2026.

Class of customers that fall within this target market

The information below summarises the overall class of customers that fall within the target market for this product, based on the product's key attributes and the objectives, financial situation and needs of the customer that it has been designed to meet.

Class of customers

The PremiumSaver Account has been designed for customers who would like a savings account to earn variable bonus interest as an incentive for growing their savings each month and have at-call access to their funds.

Product description and key attributes

PremiumSaver is a savings product that pays variable bonus interest when the account balance is grown in accordance with the applicable terms and conditions. The product also provides at-call access to funds via the nominated Linked Account held with another Australian financial institution.

The key attributes of these products are:

- A savings account with a variable interest rate and at-call access. Different interest rates may apply to different balance ranges
- Pays variable bonus interest rate when conditions are met to grow the account balance by the specified amount each month (refer to applicable terms and conditions). If the conditions are not met, interest for that month will be paid at the PremiumSaver base variable rate
- New customers are required to open and maintain a High Interest Savings Account (HISA) which is a variable rate at-call savings account which does not charge fees and has no minimum balance requirement
- No fees or charges
- No minimum balance requirement

- Must hold and nominate a Linked Account, which is an account:
 - in the same entity name as the PremiumSaver Account
 - which is owned and operated with an Australian financial institution; and
 - which can accept debits and credits
- No need to change everyday banking account. Transfer funds to PremiumSaver from an everyday account that accepts deposits and debits held with another Australian Financial Institution
- Withdrawals from the PremiumSaver Account can be made to the nominated Linked Account
- Added security using multi-factor authentication
- Deposits covered under the Australian Government's guarantee on combined balances of up to \$250,000 per account holder with Rabobank Australia Limited

Needs

The PremiumSaver Account has been designed for customers who:

- Would like to earn interest on their savings and earn a higher ongoing interest rate when their deposit balance grows
- Require at-call access to their funds
- Do not want to pay fees or charges
- Require the flexibility to make additional deposits at any time
- Would like to manage their savings account using internet and mobile banking

Objectives

The PremiumSaver Account has been designed for customers who:

- Seek to earn interest on their savings
- Seek a savings account with no minimum balance requirement
- Seek to retain their everyday banking account

Financial situation

The PremiumSaver Account has been designed for customers who have surplus funds for saving.

Excluded class of customer

The PremiumSaver Account has not been designed for customers who require branch access to their account.

Consistency between target market and product

This product is likely to be consistent with the likely objectives, financial situation and needs of the class of customers in the target market. This is based on an analysis of the key terms, features and attributes of the product and a finding that these are consistent with the identified class of customers.

Applications are subject to Rabobank Approval

Applications for the PremiumSaver Account are open to customers who meet the following requirements:

- New customers that are:
 - individuals (including Joint applicants)
 - Self-Managed Superannuation Funds (SMSF); or
 - private companies, trusts, sole traders and partnerships that meet eligibility criteria outlined in the Rabobank Online Savings application
- Each individual or trustee owner of an account must be at least 18 years old
- Each applicant must be an Australian tax resident at all times while holding the PremiumSaver Account
- Applicants are required to provide us with a valid and current:
 - email address
 - residential address and if applicable, postal address; and
 - Australian mobile phone number

We may waive any of these requirements at our discretion.

How this product is to be distributed

Distribution conditions

This product has been designed to be distributed through the following means:

- Online via links on *www.rabobank.com.au*;
- Via Rabobank Internet Banking Services including the Secure Site and Mobile App;
- Via our Call Centre; and
- Rabobank approved intermediaries including:
 - a licensed professional (e.g. a financial adviser or broker); and
 - any other appropriately licenced distributor (e.g. comparison website)

Adequacy of distribution conditions and restrictions

By distributing the products via links on *www.rabobank.com.au*, via the Rabobank Secure Site and the Rabobank Online Savings Mobile App, it means that customers are able to view information about the product as they apply for it, and determine whether it meets their financial situation, needs and objectives. This makes it more likely that customers who acquire the product are in the target market.

By distributing the products through our trained Call Centre staff we are able to provide customers with the relevant information about the product so that they are able to determine whether it meets their financial situation, needs and objectives. This makes it likely that customers who acquire the product are in the target market.

Ensuring that distribution is also through Rabobank approved intermediaries who are licensed professionals (e.g. financial advisers or brokers) will make it more likely that customers are in the target market. This is because those professionals understand the target market of this TMD, and will assist distribution in being directed towards the target market for whom the product has been designed.

By distributing the products through Rabobank approved intermediaries who are appropriately licenced distributors – particularly comparison websites – this means that customers are able to view information about the product and compare it to other similar products which may then result in them going to the Rabobank website to view information about the product to confirm whether it meets their financial situation, needs and objectives. Use of these websites makes it more likely that customers who acquire the products are in the target market.

We have therefore determined that the distribution conditions and restrictions are appropriate and will make it likely that customers who purchase the product are in the class of customers for which it has been designed.

Reviewing this target market determination

We will review this target market determination in accordance with the below:

Periodic reviews

At least every two years from the previous review

Review triggers or events

Any event or circumstances arise that Rabobank considers would suggest the TMD is no longer appropriate. This may include (but is not limited to):

- A material change to the design or distribution of the product, including related documentation;
- Occurrence of a significant dealing in the product which is not consistent with the product's TMD;
- Distribution conditions are found to be inadequate;
- External events such as adverse media coverage or regulatory attention; and / or
- Significant changes in metrics, including, but not limited to complaints

Where a review trigger has occurred, this target market determination will be reviewed within 10 business days.

Distribution Reporting Requirements

The following reporting information is collected and monitored by Rabobank and must be provided in writing to Rabobank by distributors who engage in retail product distribution in relation to these products:
